

after completion of three policy years from the date of commencement. Under this option, the policy holder can transfer policy benefits (surrender, maturity etc.) either fully or partially to another plan wherein exchange option is available. This option must be exercised at least 30 days before the receipt of benefit under the policy. The terms and conditions as specified in the opted policy document would apply to the policy holder opting for the 'Exchange Option'. The new plan would be offered on the life of the policy holder.

If the policy holder is opting for transfers from other policies to "Reliance Guaranteed Return Plan Series I - Insurance" under exchange option, the allocation charge in the year of exchange will be reduced. The reduced allocation charge applicable in the year of exchange is 2% of the Single Premium.

c) Partial Withdrawals:

Partial withdrawals are available only after a period of three years from the date of commencement of the policy or on attainment of age 18 by the life assured whichever is later. The minimum amount of partial withdrawal that can be taken at any time during the policy term is Rs. 5000 and the maximum partial withdrawal amount should not exceed 20% of the fund value at the time of withdrawal.

However, at any point of time during the policy term, the minimum fund balance after the partial withdrawal should be at least equal to 80% of Single Premium.

On a partial withdrawal, the Sum Assured will be reduced by the amount of partial withdrawals made in the preceding 24 months of the date of partial withdrawal.

The partial withdrawal charges applied are stated in the section named "Charges and Recovery of Charges under this plan or partial withdrawal of the maturity guarantee on the balance of fund will lapse.

d) Settlement Option

The policyholder has the option to take the maturity proceeds in periodic installments within a maximum of 5 years from the date of maturity. The policyholder has to give a notice to the insurer at least 30 days before the maturity date. The periodic installment could be in any form including lump sum or infrequent withdrawals as requested by the policyholder.

During the settlement period, there will be no life cover and guarantee on investment return. The policy will participate in the performance of units. There will not be any deductions towards mortality charges.

The Company will however continue to deduct administration charges by cancellation of units. The fund management charge will be priced in the unit value.

In the event of death of the Insured during settlement period the fund value as on the date of intimation of death at the office will be paid to the nominee.

During the settlement period, the investments made in the unit funds are subject to investment risks associated with capital markets and the NAV's of the units may go up or down based on the performance of the fund and the factors influencing the capital market.

The investment risk during the settlement period will be borne by the policyholder.

If settlement option is selected, then on maturity of the policy, the total fund balance would be automatically moved into Fund C, the only fund option available during the settlement period.

Charges and Recovery of Charges under this plan

a) Premium Allocation Charge:

This is a percentage of the premium appropriated towards charges from the premium received. The Premium Allocation Charges will be deducted from the premium amount before allocation of units.

If the policyholder is opting for transfer from other plan to Reliance Guaranteed Return Plan Series I - Insurance under exchange option, the reduced allocation charge in the year of exchange will be 2% of single premium.

b) Policy Administration Charge:

Policy administration charge of Rs.500 will be deducted at the outset from the single premium before allocation of units.

If settlement option is opted, policy administration charge of Rs. 40/- per month will be deducted during the settlement period by cancellation of units.

Service Tax:

The service will be levied on Fund Management Charge, Allocation charges, Mortality charge and Policy administration charge. The level of this tax will be as per the rate of Service Tax on risk premium, declared by the Government from time to time. The current rate of service tax on risk premium is 12.36% (Service tax of 12% along with education cess of 3%).

The service tax is collected as below.

- i) The Service Tax on Fund Management Charge will be priced in the unit price of each Fund on a daily basis.
- ii) The Service Tax on allocation charge will be deducted from the Single premium/contribution along with the allocation charge.
- iii) The Service Tax on Mortality charge and Policy administration charge will be deducted from Single premium/ contribution along with the Mortality charge and Policy administration charge respectively.
- iv) If settlement option is opted, then during the settlement period, the service tax on policy

In case of New Business, units shall only be allocated on the day the proposal is completed and results into a policy by the application of money towards premium.

In respect of premiums received up to 3.00 p.m. currently by the company along with a local cheque or a demand draft payable at par at the place where the premium is received, the closing unit price of the day on which the premium is received shall be applicable.

In respect of premiums received after 3.00 p.m. currently by the company along with a local cheque or a demand draft payable at par at the place where the premium is received, the closing unit price of the next business day shall be applicable.

In respect of premiums received with outstation cheques or demand drafts at the place where the premium is received, the closing unit price of the day on which cheques / demand draft is realised shall be applicable.

Redemptions

In respect of valid applications received (e.g. surrender, maturity claim, etc) up to 3.00 p.m. currently by the insurer, the same day's closing unit price shall be applicable.

In respect of valid applications received (e.g. surrender, maturity claim, etc) after 3.00 p.m. currently by the insurer, the closing unit price of the next business day shall be applicable.

The unit price for the segregated fund provided under this product shall be made available to the public in the print media on a daily basis. The unit price will also be displayed in the web portal of the company.

Cancellation of units

To pay benefits, the company will cancel sufficient units to meet the amount of the payments which are due. The units will be cancelled at the prevailing unit price.

The value of a policyholder's fund

The value of a policyholder's fund at any time is the number of units allocated to the contract at that time multiplied by the applicable unit price.

Flexibility available under this plan:

- a) Premium Payment Option
For your convenience we are providing only Single premium option. The minimum single premium amount is Rs.35,000. There is no limit on the maximum single premium amount.
You can pay the premium by cash, cheque, debit/credit card, ECS & direct debit.
- b) Exchange option:
This option is available for existing policyholders under "Reliance Guaranteed Return Plan Series I - Insurance"

Computation of NAV

When Appropriation price is applied: The NAV for a particular fund shall be computed as Market value of investment held by the fund plus the expenses incurred in the purchase of the assets plus the value of any current assets plus any accrued income net of fund management charges less the value of any current liabilities less provisions, if any. This gives the net asset value of the fund. Dividing by the number of units existing at the valuation date (before any new units are allocated), gives the unit price of the fund under consideration.

When Expropriation price is applied: The NAV for a particular fund shall be computed as Market Value of investment held by the fund less the expenses incurred in the sale of the assets plus the value of any current assets plus any accrued income net of fund management charges less the value of any current liabilities less provisions, if any. This gives the net asset value of the fund. Dividing by the number of units existing at the valuation date (before any units are redeemed), gives the unit price of the fund under consideration.

In case the valuation day falls on a holiday, then the exercise will be done the following working day.

We reserve the right to value less frequently than every day in extreme circumstances, where the value of the assets may be too uncertain. In such circumstances we may defer valuation of assets until normality returns. Examples of such circumstances are:

- a) When one or more stock exchanges which provide a basis for valuation for a substantial portion of the assets of the fund are closed otherwise than for ordinary holidays
- b) When, as a result of political, economic, monetary or any circumstances out of our control, the disposal of the assets of the unit fund are not reasonable or would not reasonably be practicable without being detrimental to the interests of the remaining unit holders.
- c) During periods of extreme volatility of markets during which surrenders and switches would, in our opinion, be detrimental to the interests of the existing unit holders of the fund.
- d) In the case of natural calamities, strikes, war, civil unrest, riots and bandhs.
- e) In the event of any force majeure or disaster that affects our normal functioning.
- f) If so directed by the IRDA.

Allocation of units

The company applies premiums to allocate units in the unit linked fund offered under this plan. The allotment of units to the policyholders will be done only after the receipt of premium proceeds as stated below:

administration charge will be recovered by cancellation of units at the prevailing unit price.

- g) Additional Charges levied by Government in future
In future the Company may decide to pass on any additional charges levied by the governmental or any statutory authority to the policyholder. Whenever the company decides to pass on the additional charges to the policy holder, the method of collection of these charges shall be informed to them.

Revision of charges

The revision in charges if any (except the service tax) will take place only after giving three months notice to the policyholders and after obtaining specific prior approval of the IRDA. The service tax will be revised as and when notified by the Government.

If the policyholder does not agree with the modified charges, they shall be allowed to withdraw the units in the plans at the then prevailing unit value after paying surrender charge if any and terminate the Policy.

Allocation Charge, Policy Administration charge, Mortality charge, Surrender charge and Partial Withdrawal charge are guaranteed throughout the term of the policy

The Company reserves the right to change the Fund Management charge. However, the maximum FMC will be 2.50% p. a.

The policy administrative charge during the settlement period is subject to revision at any time, but will not exceed Rs. 75/-.

How safe is your investment?

Unit Linked Life Insurance products are different from the traditional insurance products and are subject to the risk factors.

1. The premium paid in unit linked life insurance policies are subject to investment risks associated with capital markets and NAVs of the units may go up or down based on the performance of fund and factors influencing the capital market and the insured/policyholder is responsible for his/her decisions.
2. The Unit Price of the units may fluctuate depending on factors and forces affecting the capital markets and the level of interest rates prevailing in the market.

The Surrender Value under will be the Fund value less surrender charge.

5 day free look period:

In the event the policyholder disagrees with any of the terms and conditions of the policy, he/she may return the policy to the Company within 15 days of its receipt for cancellation, stating his/her objections in which case the Company will refund an amount equal to the non allocated premium plus the charges levied by the cancellation of units plus fund value as on the date of receipt of request in writing for cancellation.

Ex benefit:

Premium paid under Reliance Guaranteed Return Plan Series I - Insurance is eligible for tax deduction u/s 80C of the Income Tax Act, 1961 up to prescribed limits, subject to conditions. The current limit is Rs.1,00,000 subject to overall limit of Rs.1,00,000 under section 80 C of the Income Tax Act, 1961. The maturity or death benefit, tax free under section 10(10D) of The Income Tax Act, 1961, subject to conditions. You are recommended to consult your tax advisor.

Unit Pricing, Fund Valuation and Cut off Timings

Unit Price: The unit price of the fund is arrived at by dividing the Net Asset Value (NAV) of the fund by the number of units existing in the fund at the valuation date (before any new unit is allocated or cancelled)

Fund Value: The Fund Value is equal to the number of units under this policy multiplied by respective Unit Price on the relevant Valuation Date.

Valuation Date: The Company aims to value the fund on each day the financial markets are open. However, the company reserves the right to value less frequently than every day in extreme circumstances, where the value of the assets may be too uncertain. In such circumstances, the Company may defer valuation of assets until a certainty on the value of assets is resumed.

Cut-off Timings: Currently, the cut off timings is 3:00 pm for applicability of Unit Price of a particular day for allocation of units, redemption and publication of Unit Price

Method of calculation of unit values:

The unit pricing shall be computed based on whether the company is purchasing (appropriation price) or selling (expropriation price) the assets in order to meet the day to day transactions of unit allocations and unit redemptions i.e. the company shall be required to sell/purchase the assets if unit redemptions/allocations exceed unit allocations/redemptions at the valuation date.

The Appropriation price shall apply in a situation when the company is required to purchase the assets to allocate the units at the valuation date as stated above. This shall be the amount of money that the company should put into the fund in respect of each unit it allocates in order to preserve the interests of the existing policyholders.

To policy of life insurance effected before the commencement of this Act shall after the expiry of two years from the date of commencement of this Act and no policy of life insurance effected after the coming into force of this Act shall, after the expiry of two years from the date on which it was effected, be called in question by an insurer in the ground that statement made in the proposal for insurance or in any report of a medical officer, or referee, or friend of the insured, or in any other document leading to the issue of the policy, was inaccurate or false, unless the insurer shows that such statement was on a material matter or suppressed facts which it was material to disclose and that it was fraudulently made by the policy-holder and that the policy-holder knew at the time of making it that the statement was false or that it suppressed facts which it was material to disclose.

Provided that nothing in this section shall prevent the insurer from calling for proof of age at any time if he is entitled to do so, and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof that the age of the life assured was incorrectly stated in the proposal.


